# **RULES OF THE MARATHON POUR TOUS<sup>1</sup>**

# Version updated on 19 January 2024

### **PREAMBLE**

The Marathon Pour Tous (hereinafter the **Event**) will take place in Paris on 10 August 2024, starting at 9pm for the Marathon and 11.30pm for the 10-kilometre race. It is organized by Paris 2024, the Organising Committee for the Paris 2024 Olympic and Paralympic Games (Comité d'Organisation des Jeux Olympiques et Paralympiques (COJO), a registered association listed on the SIRENE register under ID no. 834 983 439, and whose head office is located at 46 Rue Proudhon in Saint-Denis (93210) (hereinafter **Paris 2024** or the **Organiser**).

These rules and regulations (hereinafter the **Rules**) apply, without restriction or reservation, to (i) all participants in the Event (hereinafter the **Participant**) once they have signed up for a Marathon Pour Tous race, (ii) if the Participant is a minor in their country of residence, to their legal representative or guardian, and (iii) if the Participant requires support or assistance, to the Participant's companion.

The Rules replace the Terms and Conditions of Use of the Marathon Pour Tous race bib.

Paris 2024 reserves the right to amend the Rules, in particular for reasons imposed by the competent authorities, of which Participants will be informed.

## 1. THE EVENT

## 1.1 Events and race management

The Event consists of two races:

- A marathon of 42.195 kilometres,
- And a 10-kilometre event.

Details of the race routes will be posted on the event website: <u>marathonpourtous.paris2024.org.</u>

The Event does not benefit from any certification or recognition by the French Athletics Federation.

There will be no official jury; the races will be managed by Paris 2024. Race times are therefore not considered official times.

### 1.2 Race times without ranking

The Event is timed to allow you to record your individual sporting performance, and will not be consolidated in an overall ranking. No race times will be published, and no ranking of Participants will be carried out at the end of the Event.

Times will be displayed every five (5) kilometres as well as at kilometre 21.1 and at the finish.

You will be given an electronic chip when you pick up your race number (chip in the form of a strip stuck on the back of each bib) which will be automatically triggered at the starting line and will be used to time and track competitors every five (5) kilometres and at the finish. For the chip to work properly, it must not be bent or damaged.

If you do not follow the race route, as marked out by the Organiser by human and/or material means, you cannot be considered to have completed the race and will not be timed on certain sections if certain checkpoints have not been crossed.

The electronic detection system has been selected according to strict reliability criteria. Despite tests carried out by the manufacturer, there is always a very low possibility of a detection failure. Any absence of data resulting from such a detection failure will mean the Organiser cannot provide you with your individual race time. The Organiser may not be held liable for this.

#### 1.3 Time limit

If you take part in the marathon event, you will have a maximum of six (6) hours to complete the course to the finish line.

If you take part in the 10-kilometre event, you will have a maximum of two (2) hours to complete the course to the finish line.

This corresponds to an average speed of seven kilometres per hour (7 km/h).

At any time during the Event, any participant who fails to meet this average pace, materialised by the Organiser's end-of-race vehicle, may be disqualified by the Organiser without any liability on the part of the Organiser.

The disqualified Participant will be offered a ride to the finish area.

After the end-of-race vehicle has passed, you must comply with the traffic regulations of the Highway Code on the Event route.

#### 2. CONDITIONS OF PARTICIPATION

Subject to compliance with the Rules, which you (or your legal guardian if you are a minor) acknowledge having read and accepted all clauses, in order to enter and participate in the Event, you must satisfy the following conditions.

## 2.1 Obtaining a Marathon Pour Tous race number

To take part in the Event, you must have obtained a Marathon Pour Tous race number.

You will be able to take part in the race for which you have obtained a race number.

The Marathon Pour Tous race number can be obtained through one of the various channels offered by Paris 2024 and its partners, including:

- Participation in competitions on social media
- Participation in sporting challenges on the Marathon Pour Tous app
- Participation in sporting events organised by Paris 2024 or its partners
- Participation in local sporting events
- Participation in the Paris 2024 Club draw
- Application for a race number through a Paris 2024 partner.

Please note that all beneficiaries of a Marathon Pour Tous race number must be a member of Club Paris 2024 or any equivalent scheme approved by Paris 2024.

## 2.2 Age requirements

To participate in the Event, you must be at least:

- twenty years (20 years) in the year of the event for the marathon and
- sixteen (16) years of age in the year of the event for the 10k race.

If you are taking part in the 10k race and you are a minor, the team in charge of approving entries will ask you for permission from your legal guardian, as well as a certificate authorising us to use your image. To this end, you will receive a document by email containing these authorisations, to be filled in and signed.

This document, duly completed by the Participant's legal guardian, must be returned to secure final validation of your race entry.

### 2.3 Medical certificate

You must have a medical certificate dated less than one year before the date of the Event, stating the lack of any contraindication to the practice of:

- o "l'athlétisme en compétition" ("competitive athletics");
- o "la course à pied en compétition" ("competitive running events");
- "le sport en compétition" ("competitive sport").

The medical certificate must be signed by a doctor, whose signature can be authenticated, whether or not he or she is based in France. If the doctor is not based in France, the medical certificate must be written in French, English, Spanish, German, Italian or Portuguese

You are required to provide a medical certificate even if you hold a competitive licence issued by a World Athletics-affiliated federation or any other international sports federation.

At least 15 days before the event, you must upload your medical certificate via the tool on the registration platform: https://in.marathonpourtous.paris2024.org/marathon-pour-tous-2024, for validation by the Organiser. You will therefore need to check your account to ensure that your document has been approved. Any medical certificates sent by post or email will not be accepted.

In all cases, you must have a copy of your medical certificate when collecting your race number and during the Event.

The authenticity of medical certificates may be checked on site at the Event, even in cases where you have uploaded your medical certificate to your account. You must therefore be able to provide it when you pick up your number or during the Event.

## 2.4 Accessibility

The Event is accessible to people with disabilities, subject to the conditions and limitations set out in this Article.

- For people with disabilities requiring assistance:

Participants with disabilities who have declared their situation when confirming the Terms and Conditions of Use of the Marathon Pour Tous race number agree (i) to provide all supporting documents relating to their request for assistance (guide, assistance, etc.) and (ii) that the person accompanying them complies with the Terms and Conditions of Participation set out in this Article 2 of the Rules.

- For Wheelchair Users (hereinafter **WU**) competing in the Marathon race:

By accepting these Rules, if you are a wheelchair user taking part in the Marathon (42.195 kilometres), you agree to abide by all the conditions set out below.

- We recommend that you familiarise yourself with the demanding nature of the Marathon race and make sure that you are capable of completing the Marathon course within a maximum of six hours.
- You'll be able to use your regular wheelchair as long as you install a third front wheel to stabilise it. This wheel cannot be driven (electric power-assist is not permitted).
- The use of competition wheelchairs (such as Paralympic marathon wheelchairs), or any other wheelchair requiring manual action, will be authorised.
- Joëlettes (or "josettes") requiring assistance will be allowed to take part and will form part of the total number of Participants authorised to compete in wheelchairs.
- Gear-driven devices are not permitted.
- Electric wheelchairs or any other non-manually propelled wheelchair will not be allowed.
- Because the course is so demanding, you will need a braking system that's simultaneously
  present on both wheels of the wheelchair, to cope with the course's two major descents,
  with gradients of 15%. Depending on the system used, Paris 2024 reserves the right to
  impose technical and/or human support during these two descents. Similarly, Paris 2024
  reserves the right to impose human support for uphill sections, depending on the conditions
  at the time (weather conditions, crowds on the race route).
- The maximum number of WUs is set at 50 Participants. Paris 2024 reserves the right to increase or decrease the number of Participants depending on requests and profiles.

If you are unable to comply with any of these conditions, please contact the organisation team at the following address: <a href="mailto:participants@mpt.paris2024.org">participants@mpt.paris2024.org</a>, to discuss the possibility of entering the 10 kilometre event or to benefit from assistance. Paris 2024 also reserves the right not to authorise your departure if these conditions are not met, and may not be held liable for this.

#### 3. HOW TO SIGN UP FOR THE EVENT

After validating the Terms and Conditions of Use of the Marathon Pour Tous race number, Paris 2024 will send the Participant a single-use login link enabling them to access the registration platform.

Entries are submitted on the registration platform: https://in.marathonpourtous.paris2024.org/marathon-pour-tous-2024.

When the user logs in, they will be asked to use their Paris 2024 account username and password.

If the Participant does not have a Paris 2024 account at the time of registration, they must first create a Paris 2024 account and profile.

After logging on to the registration platform, the Participant must fill in a form and unconditionally accept the Rules.

The Participant undertakes to provide only truthful information.

Once your registration is complete, you will receive an email confirming your registration.

Your invitation to the Event will be available for download on the registration platform prior to the Event. You will be informed by email.

Entering the Event is free of charge.

Entries submitted by any means other than the above (e.g. by email, post or hand-delivery) will not be accepted.

Please note that the final validation of your registration will be subject to compliance with the terms and conditions of participation, set out in Article 2 of the Rules.

#### 4. WITHDRAWAL AND WEARING OF RACE NUMBERS

To collect your race bib, you will need to present the following documents:

- Your medical certificate meeting the aforementioned conditions,
- Your invitation, available to download from your account and/or sent by email prior to the event,
- An official, valid form of ID (limited to a National ID Card or Passport).

Race numbers can only be collected in the dedicated collection area on Friday 9 August and Saturday 10 August 2024, from 10am to 8pm. Race bib collection area: Stade Emile Anthoine, 2 Avenue de Suffren, 75007 Paris

Only Participants will be allowed to access the collection area. Any accompanying persons will not be allowed on the premises, with the exception of legal guardians of minors.

Collecting race numbers for others will not be permitted.

No race numbers will be sent by post, nor will they be handed out in the start area of the Event.

Allocation of the race number to a Participant is firm and final. The race number is not transferable to a third party, under penalty of exclusion from the Event.

From the moment you enter the Event route (including the start and finish areas) and for the entire duration of the Event, you must make sure the race bib supplied by the Organiser is visible, by attaching it to the front of your T-shirt at chest level.

#### 5. RUNNING OF THE EVENT

### 5.1 Access to Event Sites and security

In order to take part in the Event and access the Site(s) on which the Event takes place (including the bib collection area, the Event route, and the start and finish areas) (hereinafter **Event Site(s)**), you acknowledge and expressly accept that the Organiser may call upon security personnel, who will be authorised to carry out checks both on Participants and their personal belongings. If you wish to access the Event Sites, you agree to submit to this check. If you refuse to do so, you will not be allowed to take part in the Event or access the Event Sites.

It is strictly forbidden to bring any objects to the Event Sites that may be dangerous or illegal, in particular drugs, firearms, blunt weapons and explosives.

Participation in the Event is forbidden to all wheeled vehicles, other than those belonging to the organisation or accepted by the Organiser, as well as to animals.

Headphones or earphones are not forbidden but remain the responsibility of the Participant. That said, for obvious safety reasons, the Organiser strongly advises against the use of devices that could interfere with being able to hear the surrounding environment during the Event.

The Organiser and security staff may refuse access to the Event or prevent Participants from taking part in a race if their behaviour is likely to disturb the smooth running of the Event notably under the following, non-exhaustive circumstances: introduction of any object that could potentially hinder or present a risk in any way whatsoever to the running of the Event, traffic and/or the safety of other Participants; the use of any distinctive promotion, in any form, of an opinion [political, philosophical or religious] likely to damage the image of the Event; abnormal, inappropriate or amoral behaviour, especially if you appear to be under the influence of drugs or alcohol.

The Event takes place on roads closed to traffic. Nevertheless, after the end-of-race vehicle has passed, you must comply with the traffic regulations of the Highway Code on the Event route.

More generally, each Participant must follow the safety instructions provided by the Organiser during the Event, or risk disqualification.

#### 5.2 Services

During the Event, road safety is ensured by the Préfecture de Police de Paris and medical service by the Organiser's service provider, assisted - where appropriate - by the Croix Rouge Française and Protection Civile Paris Seine, in accordance with a system approved by the Préfecture de Police de Paris.

Medical teams may decide to take you out of the race for medical reasons. Under no circumstances may you hold the Organiser liable for failure to finish the event as a result of such a decision.

There is a locker area where you can leave your personal belongings and collect them after the event. This locker area will be only accessible to marathon distance (42,195km) participants.

### 5.3 Refreshments

Refreshment points will be set up approximately every five (5) kilometres along the route and after the finish line for all Participants.

Water points will be set up approximately every five (5) kilometres along the route, starting at kilometre seven point five (7.5).

#### 5.4 Checks

Checks may be carried out during the Event by the Organiser or any person appointed by the Organiser in order to verify compliance with race conditions, in particular compliance with age and medical certification requirements.

You hereby acknowledge that the Organiser has the right to refuse your participation or even exclude you from the Event in the event of non-compliance, without the Organiser being held liable.

## 5.5 Aerial photography

You are informed that, on the day of the Event:

- remotely piloted aircraft (drones) may be used for photos or filming;
- during all or part of your participation in the Event, you may come within thirty (30) metres of said drones;

If necessary, you will be given safety instructions which you must follow.

## 6. HEALTH PROTOCOL

To ensure your health and safety and that of all Participants, the Organiser may issue a health protocol (hereinafter **Health Protocol**) which may include the obligation to present, on the day of collection of the race number or the day of the Event, a document attesting to non-infection by the virus concerned by the Health Protocol.

In order to take part in the Event, you must strictly comply with the aforementioned Health Protocol and acknowledge the Organiser's right to refuse your participation/access to the Event for failure to comply with the measures set forth, without the Organiser being held responsible or liable in any way.

You will be informed of the provisions of this Health Protocol by email sent to the address provided at the time of your registration or by an announcement on the Event website marathonpourtous.paris2024.org .

The nature of the documents to be provided, and where applicable the document certifying non-infection, will be determined by the Organiser, taking into account in particular the requirements of the competent authorities and the status of scientific and technical knowledge, particularly with regard to screening, on the day of the Event. This may take the form of a sworn statement of non-infection, a PCR or antigen test result or any other type of test performed within the appropriate timeframe prior to the Event, which will be stipulated.

As this document contains health data, it will only be viewed/consulted by the Organiser's relevant personnel when collecting race numbers and/or during the Event.

None of this data will be kept by the Organiser.

In the event of failure to comply with this condition of entry laid down by the Organiser, the details of which will be provided later, you will not be able to collect your race number and will not be able to take part in the Event, without the Organiser being held responsible or liable in any way.

#### 7. COMMITMENTS AND OBLIGATIONS OF PARTICIPANTS

At the risk of losing the benefit of your registration and the rights attached thereto, and without prejudice to the other commitments and obligations of Participants set forth in these Rules:

- you agree not to transfer to a third party, whether free of charge or in exchange for payment, any of the rights you have acquired through your registration. The benefit of registration is strictly personal and may not be transferred for any reason whatsoever. Any person accessing the Event in this way will also be sanctioned and will not be able to take part in the Event.
  - In particular, if you pass your number on to a third party, you will be held responsible in the event of an accident involving or caused by the third party during the Event. The Organiser refuses to be held liable should an accident occur in this type of situation;
- you agree to provide any information requested by Paris 2024, in accordance with the procedures and within the deadlines stipulated by Paris 2024, in order to organise and guarantee the safety of the Marathon Pour Tous events (for example, race times already achieved);
- you confirm that the information and documents submitted to Paris 2024 during your membership of the Paris 2024 Club, or any equivalent scheme validated by Paris 2024, and until the end of the MPT events, are truthful and accurate. In particular, you undertake not to usurp the identity of another person or entity, falsify or conceal your identity or age, or create a false identity of any kind.
  - It is your responsibility to keep this information up to date with Paris 2024, as and when required, by notifying it of any changes affecting it, at marathonpourtous@paris2024.org. In the absence of any updates, Paris 2024 cannot be held responsible for any prejudicial consequences for you (including the impossibility of participating in the Event);
- you must ensure the confidentiality of your login details for your Paris 2024 Club account, or for any other equivalent scheme validated by Paris 2024, for which you are solely responsible, and undertake in particular not to disclose these to a third party, other than your legal representative if you are a minor, (even to a member of your family, or a friend) and not to use those of another Participant.

You agree to immediately notify Paris 2024 at marathonpourtous@paris2024.org if you suspect any unauthorised use of your login details.

### 8. RESPECT FOR THE ENVIRONMENT

To respect the environment, it is strictly forbidden to throw waste (paper, plastic packaging, etc.) along the race route. Rubbish bins, and where appropriate recycling bins, will be available at each

refreshment point, and "collection zones" will be set up and signposted at various points along the route. You must make sure to use them.

You should hold onto your litter and wrappers and wait until you reach the areas set up by the Organiser to dispose of them.

The Organiser reserves the right to disqualify you if you deliberately dispose of your waste outside of the marked areas.

#### 9. RESPECT FOR OLYMPIC AND PARALYMPIC VALUES

Until the end of the Event, you undertake to respect the values and principles of Olympics and Paralympics defined respectively in the Olympic Charter of the International Olympic Committee ("IOC") and in the Code of Ethics of the International Paralympic Committee ("IPC"), extracts of which are provided below:

"The Fundamental Principles of Olympism

- 1. Olympism is a philosophy of life, exalting and combining in a balanced whole the qualities of body, will and mind. Blending sport with culture and education, Olympism seeks to create a way of life based on the joy of effort, the educational value of good example, social responsibility and respect for universal fundamental ethical principles.
- 2. The goal of Olympism is to place sport at the service of the harmonious development of humankind, with a view to promoting a peaceful society concerned with the preservation of human dignity.
- 3. The Olympic Movement is the concerted, organised, universal and permanent action, carried out under the supreme authority of the IOC, of all individuals and entities who are inspired by the values of Olympism. It covers the five continents. It reaches its peak with the bringing together of the world's athletes at the great sports festival, the Olympic Games. Its symbol is five interlaced rings.
- 4. The practice of sport is a human right. Every individual must have the possibility of practising sport, without discrimination of any kind and in the Olympic spirit, which requires mutual understanding with a spirit of friendship, solidarity and fair play.
- 5. Recognising that sport occurs within the framework of society, sports organisations within the Olympic Movement shall have the rights and obligations of autonomy, which include freely establishing and controlling the rules of sport, determining the structure and governance of their organisations, enjoying the right of elections free from any outside influence and the responsibility for ensuring that principles of good governance be applied. »

## "Preamble to the IPC Code of Ethics

The International Paralympic Committee (IPC), its members, partners, officials, sportsmen and sportswomen affirm their commitment to the Paralympic ethos, which is rooted in the history of the Paralympics and the tradition of fair and honourable sports competition. Paralympic history and tradition are based on the principles of excellence in sport, opportunity to participate in fair competition, and enhancement of the dignity of athletes and sport. This necessitates acceptance of the fundamental values of honesty, human rights, fairness, justice, nondiscrimination and personal integrity.

Members of the Paralympic Family shall endorse the vision, mission and values of the IPC and shall respect all IPC codes, policies and rules.

The IPC is an athlete centred organisation. The athletes' interests, priorities, and opportunity to participate in fair competition and excel in sport are the main objectives of the IPC. »

Consequently, each Participant undertakes to conduct themselves in a respectful manner and not to behave in such a way as to hinder, inconvenience, threaten or endanger the organising bodies of the Paris 2024 Olympic and Paralympic Games (the IOC, Paris 2024, the NOCs, the IPC, etc.), the other Participants, the public, staff and volunteers involved in the organisation of the Event, but also the teams in charge of security and the forces of law and order.

In particular, it is forbidden to:

- contribute to jostling or slipping;
- enter any area of the organisation where official Paris 2024 accreditation is required;
- sell or resell on the Event Sites any promotional or commercial item or object without the prior authorisation of Paris 2024;
- behave in any way likely to harm others, affect the smooth running of the Event or negatively effect Paris 2024. Any Participant who appears in an obvious state of intoxication at the entrances to the Event Sites will be refused access to the Event. Similarly, Paris 2024 reserves the right to exclude from the Event any person who is intoxicated inside the Event Sites;
- propagate or disseminate abusive, sexist, racist, political, religious, discriminatory or prohibited language or messages in or around the Event Sites;
- orchestrate or participate in the propagation or dissemination of commercial messages that may constitute ambush marketing activities (for example, a group of spectators in the same area of an Event Site wearing clothing bearing commercial messages);
- carry out an unauthorised protest/demonstration in or around the Event Sites, whether for commercial purposes (including ambush marketing), or for militant or personal reasons;
- disrupt or attempt to disrupt the operation of services, in particular technical services, related to the organisation of the Event (in particular by jamming the radio broadcasts of an authorised service or by hacking into Paris 2024's computer or audiovisual systems);
- conduct any commercial activity whatsoever, or offer (free or for sale), sell or hold items with the intent to sell (including, without limitation, beverages, food, souvenirs, clothing, promotional and/or commercial items and literature), in each case without the prior written permission of Paris 2024.

#### 10. NON-REFERENCE AND USE OF OLYMPIC AND PARALYMPIC PROPERTY

In France, the following are protected by French literary and artistic property law and/or as well-known trademarks and by Articles L.141-5 and L141-7 of the French Sports Code:

- firstly, the Olympic symbol (the Olympic Rings), the flag, the motto, the anthem, the identifications (including, but not limited to, "OLYMPIC(S)", "OLYMPIADE(S)" and the "OLYMPIC GAMES" or "JO"), the designations, emblems, Olympic flame and torches, as well as any musical or audiovisual works, creations or objects commissioned in connection with the Olympic Games by the IOC, the NOCs and/or the OCOGs, as well as Paris 2024, designating the world-famous sporting event, exclusive property of the IOC the Olympic Games as well as the products and services related to their organisation, and
- secondly, the Paralympic symbol (the Agitos), the flag, the motto, the anthem, the identifications (including, but not limited to, "PARLYMPIC(S)", "PARALYMPIADE(S)" and the "PARALYMPIC GAMES" or "JP"), the designations, emblems, Paralympic flame and torches, as well as any musical or audiovisual works, creations or objects commissioned in connection with the Paralympic Games by the IPC, the NPCs and/or the OCOGs, as well as Paris 2024, designating the world-famous sporting event, exclusive property of the IPC the Paralympic Games as well as the products and services related to their organisation,

## (hereinafter Olympic and Paralympic Property).

Consequently, you agree not to use the Olympic and Paralympic Property in any way whatsoever without the prior express authorisation of Paris 2024.

You hereby undertake, including in any communications relating to your registration or participation in an Event, to:

- never associate yourself or your image, or products and services or trademarks, logos, acronyms, emblems or any other distinctive sign belonging to you in any way with the Olympic Games, the Paralympic Games, the Olympic and Paralympic Movement, the IOC, the IPC or Paris 2024;
- never use or create a direct or indirect illegal or unauthorised association with the registered or unregistered trademarks, logos and any other distinctive sign of Paris 2024, of the IOC, the IPC, the Olympic and Paralympic Movement, the Olympic Games, the Paralympic Games and Paris 2024;
- never claim, publish or make any communication regarding your status as an "official",
   "selected", "approved", "guaranteed" or "privileged" service provider or partner of, or for the
   benefit of, the IOC, the IPC, Paris 2024, the Olympic and Paralympic Movement, the Olympic
   Games or the Paralympic Games, or any other similar status;
- never use a trademark, brand name, logo or any other communication medium likely to create confusion with Paris 2024, the IOC, the IPC, the Olympic and Paralympic Movement or the Olympic and Paralympic Games, or engage in any form of ambush marketing that enables you to take advantage of the reputation of the Games without paying for it;
- never carry out any action or communication likely to prejudice partners, suppliers, licensees or
  any entity with which the IOC, IPC and/or Paris 2024 has contracted or may contract in the
  future. In this respect, the Participant agrees not to wear any obviously visible commercial
  brands, in particular on his/her clothing, with the exception of the brands of partners duly
  authorised by Paris 2024;
- never register any trademarks, designs, models, texts, symbols, slogans, or any other intellectual property rights, etc. related to the Event or directly or indirectly related to the Olympic and Paralympic Movement, the Olympic Games, the Paralympic Games or Paris 2024.

Lastly, you undertake not to present or use any advertising whatsoever in connection with the trademarks and distinctive signs of the IOC, the IPC, the Olympic and Paralympic Movement, the Olympic Games, the Paralympic Games and Paris 2024 in connection with obtaining your race number, or any communication relating to its collection, and your participation in an Event race.

Consequently, you guarantee Paris 2024 against all financial or other type of consequences related to a breach of the commitments listed above, whether the violation is your fault or the fault of a third party with whom you are associated. These obligations and guarantees will continue after the end of the Event.

#### 11. MATERIAL DAMAGE SUFFERED BY THE PARTICIPANT

The Organiser shall not be held liable for damage to the Participant's personal belongings during the Event, whether theft, breakage or loss, including when these personal belongings are deposited in a locker provided by the Organiser.

The Organiser would like to remind Participants of the importance of taking out a property insurance policy to cover any material damage to which they may be exposed during the Event.

Participants are therefore advised to discuss the situation with their insurer, who will be able to offer the appropriate cover for the Participant's personal situation.

#### 12. INSURANCE

**Civil liability:** In accordance with current legislation, the Organiser has taken out insurance covering the financial consequences of its civil liability, that of its officials and that of all the Participants in the Event.

**Personal accident:** The Organiser would like to remind Participants of the importance of taking out a personal insurance policy to cover any bodily injury to which they may be exposed as a result of their sporting activities. Participants are therefore advised to discuss the situation with their insurer, who will be able to offer the appropriate cover for the Participant's personal situation.

### 13. USE OF IMAGES

### 13.1 Participant's image

Participants may be filmed, photographed, identified and/or otherwise recorded on the Event Sites. The images of Participants taken on this occasion may be used, along with the related data, as part of the Event coverage and, more broadly, coverage of the Paris 2024 Olympic Games, or to inform the public of the holding of the Event and the Paris 2024 Olympic Games or the Olympic and Paralympic Games in general, and to promote the Olympic and Paralympic Movements.

All Participants authorised to take part in the Event through the granting of a race number agree to be filmed, photographed, identified and/or recorded in any other way on the Event Sites by the IOC, the IPC Paris 2024 and by any third party authorised by the IOC, the IPC or Paris 2024. They also agree that the images taken or recorded of them, as well as their name, appearance, voice, performance and biographical data may be used, in particular for reproduction, distribution, communication to the public and made available, in any content, in any format and via any medium or technological means that currently exist or may be created in the future, without consideration (financial or otherwise), by Paris 2024, the IOC, the IPC, entities affiliated to the IOC or the IPC, and/or by third parties authorised by them, such as the Organising Committees of the Olympic and Paralympic Games or the Youth Olympic Games, the National Olympic and Paralympic Committees, international sports federations, Olympic marketing partners (TOP partners and organisations holding radio and TV rights), national partners, media and social media organisations, during or after the Paris 2024 Olympic Games, for the maximum period authorised by the legislation in force, in connection with the preparation, operation, celebration and direct or indirect promotion of the Event and the Paris 2024 Olympic and Paralympic Games, the Olympic and Paralympic Movements, and/or the IOC and IPC and their activities, or referring thereto, for commercial and non-commercial purposes, excluding any use that creates, without the Participant's written consent, a direct commercial association between their image and any product or service of a third party.

If the Participant, under the law applicable in their country of residence, is a minor or does not have the necessary legal capacity, or in any case is under 18 years of age, this authorisation is granted by the holder of parental authority or the designated legal representative, on their

behalf, and on behalf of any other holder of parental or legal authority, with the consent of their child or protected adult, depending on their age, degree of maturity and capacity.

Participants acknowledge that the IOC holds various exclusive rights over the Event and the Olympic Games (including the Games), in accordance with Article L.333-1 of the French Sports Code, as well as, where applicable, copyright and trademark rights. Participants understand that such exclusive rights prohibit the commercial exploitation and provision to the public of photographs, sound recordings or videos of the Games by any person or entity not expressly authorised to do so by the IOC and/or Paris 2024.

# 13.2. Event Images

Any communication of still images and/or animated sequences of the Event, at your initiative, captured during your participation in the Event, including during the collection of race numbers and at the start and finish areas of the Event, must be limited to personal use and may under no circumstances be used for promotional and/or commercial purposes outside the Event.

#### 14. PERSONAL DATA

You are informed, or if you are a minor your legal representative is informed, that Paris 2024 collects, records and uses personal data about you as part of your participation in the Marathon Pour Tous.

You undertake to provide only the personal data required by Paris 2024.

You agree not to provide any sensitive data (racial origin, political opinions, etc.), in which case Paris 2024 will not process such data.

In accordance with the regulations in force, you have the right to access, rectify, delete and object to all personal data relating to you and held by Paris 2024, as well as the right to portability, by writing and email and providing proof of your identity, to: DPO@paris2024.org.

In the event of any unresolved problems or complaints, you may refer the matter to the Commission Nationale de l'Informatique et des Libertés (CNIL): www.cnil.fr.

## Live Tracking -

By choosing to take part in the Event, you acknowledge that your progress on the route will be accessible to any user following the Event via the "Live Tracking" tool accessible from the Event website, using the timing chips every time you pass a checkpoint approximately every five (5) kilometres.

You acknowledge that any user of the app or the internet may track you by entering your first and/or last name and/or race number.

## **15. PENALTIES**

Paris 2024 reserves the right to withdraw, *ipso jure*, and with immediate effect, the benefit of your entry in a Marathon Pour Tous race or to exclude you from the Event, with no right to compensation, if you fail to comply with the Rules or commit any actions or oversights that may reasonably be considered by Paris 2024 to be incompatible with the Rules, in particular if they are contrary to the values of Olympism and Paralympism, such as:

- Failure to comply with commitments under the non-reference clause;
- Failure to comply with the duty of neutrality;
- Transfer of a race number to a third party;
- Failure to communicate the information requested by Paris 2024, or by any third party appointed by it, for the purposes of organising the Marathon Pour Tous or registering for the Marathon Pour Tous;
- Behaviour or practice deemed irresponsible by Paris 2024 that may endanger property or people (e.g. false information, disrespectful or insulting comments about the Olympic family, incivility, use of doping products, etc.).

#### 16. PARTICIPANT'S DISCLAIMER

If, for any reason whatsoever, you are unable or no longer wish to take part in a Marathon Pour Tous event, please inform Paris 2024 immediately by sending an email to participants@mpt.paris2024.org. Any withdrawal forfeits the benefit of the registration upon receipt by Paris 2024.

#### 17. EVENT CHANGES - POSTPONEMENT - CANCELLATION

Paris 2024 reserves the right to cancel all or part of the Marathon Pour Tous events, to modify the format (programme, route, location, date, schedule, duration, etc.), to stop the Event in progress or to set up a fall-back route if circumstances require it to do so, in particular at the request of the competent administrative authorities, or in the event of *force majeure* (such as extreme weather, natural disaster, changes in health restrictions, an external security risk, etc.), without being held liable for any reason whatsoever.

Participants will be informed of any changes by all possible means, and must strictly comply with the Organiser's instructions. Failure to comply with these instructions will automatically result in the end of the Organiser's liability.

## 18. NO COVERAGE OF COSTS

Paris 2024 will not cover any expenses (including transportation and accommodation) that you may incur, in particular in preparation for or participation in the Event.

More generally, because entering and taking part in the Event is free of charge, the benefit of registration may not be contested in any way, nor may it be exchanged for cash or replaced for any reason whatsoever. Consequently, no claim of any kind will be entertained in this respect. Paris 2024 will not compensate you if you do not wish or are unable to use the benefits of your registration for any reason whatsoever.

# 19. COMPLAINTS/DISPUTES

Any complaints must be submitted in advance in writing to marathonpourtous@paris2024.org to enable the parties to attempt to reach an amicable solution.
